### **Section One. Our Promise**

We, Companions Forever, verify this puppy is healthy, happy, and ready for his/her forever family. He/She is current on vaccinations, deworming's, and the customer is being given a record of all vaccinations and deworming's. This puppy is guaranteed to be in good health, verified by veterinarian certification.

### **Section Two. 72 Hour Vet Check Requirement**

**The seller warrants that at the time of delivery the puppy(s) is/are in good health and has/had already been examined by a licensed veterinarian. Buyers are required to have the puppy(s) examined again within 72 hours of delivery by a licensed veterinarian. If the veterinarian finds the puppy(s) to have a life-threatening condition, then upon verification of this condition to the Seller, Seller agrees to replace the puppy(s) of the same breed upon the return of the puppy(s). In the event that puppy(s) have been shipped SELLER WILL NOT REFUND SHIPPING FEE. ALL VETERINARIAN FEES OR ASSOCIATED CAOST ARE TO BE BORNE BY THE BUYER.**

### **Section Three. One Year Health Guarantee**

**1 YEAR HEALTH GUARANTEE:** This puppy is guaranteed against any genetic diseases/disorders. The customer shall provide proper nutrition, vet care, shelter, and exercise, along with socialization, and obedience. In the event of any genetic diseases/disorders within the first year, a veterinary statement of diagnosis and x-rays must be given to Companions Forever then a replacement puppy or refund will be given.

**The following are NOT covered by this guarantee:**

- Reimbursement for veterinary expenses
- Reimbursement for air transport or return
- External parasites, such as ticks, fleas, or ear mites
- Internal parasites, such as intestinal worms, or their effects (almost every puppy has some sort of intestinal worms: although we have wormed your puppy regularly, it only takes a few days for him/her to pick up another "batch." That's just a part of puppy hood, which is why a regular worming schedule is recommended.)

## Section Four. Recover

**First Right of Recover:** If at any point the customer is unable to properly care for this puppy, Companions Forever has the right of recovery, at the cost of the customer. This puppy may never be surrendered to a shelter or rescue. Neither can this puppy be abused, neglected, or mistreated in any way.

The parties waive trial by jury and agree to submit to the personal jurisdiction and venue of a court of subject matter jurisdiction located in LaGrange, Indiana. If litigation results from or arises out of this agreement or the performance of it, the parties agree to reimburse the prevailing party's reasonable attorney's fees, court costs, and all other expenses, whether or not taxable by the court as costs, in addition to any relief to which the prevailing party may be entitled.
